Summary of Activity this Period

- Rating Task Force:
 - Combined HD and LD workshop was conducted the week of March 6, 2023, in San Antonio.
 - Test labs only at this workshop.
 - Data indicated raters are in a good spot.
 - Three new tools in play
 - LED lights approved
 - JMP for real-time evaluations and visuals
 - New web-based data input system
 - Very well received and managed
 - Next workshop will be October 17 -19 in San Antonio and will be a field test workshop.

Activity this Period (cont'd)

- Fuels Task Force Activities:
 - No activity this reporting period: all action items completed
 - Group will reconvene as new items are added to the list.
- The DACA II Review Task Force
 - One additional item has been brought to the groups attention that will need some discussion before the draft DACA III document with all incorporated changes can be released for final review by the task force.
 - Estimated to complete this by December 2023 meeting.

Activity this Period (cont'd)

- Surveillance Panel Chair Handbook
 - Lots of activity this reporting period.
 - Several subgroups created to handle the individual topics that will be included in the workbook. These individual groups have already met virtually.
 - One of these subgroups is discussing stats topics. In-depth discussion on the potential need for more structure on how the stats group prioritizes the many data analysis requests.
 - One proposal was a new section under D02.B
 - Some think this will bog down the process that seems to be working now.
 - Action item for the TGC is to solicit voting members as to their opinions whether there is a need to add more structure.

Activity this Period (cont'd)

- Stats group will be working towards performing annual training to help advise on the diverse topics that support our testing. A discussion took place on the best time to conduct this training.

The options discussed were as follows:

- During ASTM week
- Scheduled as a separate meeting
- Help during the PCMO surveillance panel week

Nothing was decided at this point; will be discussed further at future meetings.



Reference Oil Shipment Overview*






Reference Test Activity*






