SUBJECT:	ASTM TMC Semiannual Report

ADMINISTRATIVE/FINANCIAL

The TMC financial audit for the period February 1, 2010 through December 31, 2010 is scheduled for February 22, 2011 by Lally, Lally & Co. LLC. The audit will be based on an 11 month fiscal year so that the TMC fiscal year can be aligned with ASTM headquarters fiscal year start of January 1. The current financial status of the TMC will be part of the Administrative Guidance Committee report.

Ellen Young, TMC Accountant, will be retiring January 3, 2011 after 21 years of service. Barbara Parker, TMC Clerk/Receptionist, will be retiring January 7, 2011 after 23. Colleen Barry has been promoted to Accountant from her previous Computer Group duties. A replacement for Colleen in the Computer Group will be hired in the 1st quarter of 2011. The TMC staff count will be going from 15 full-time employees to 14 in 2011. These retirements and position changes leave the TMC without clerical/receptionist staffing. The updated TMC organizational chart is shown in Attachment A.

The contract between ASTM and Carnegie Mellon University (CMU) was renewed for three years on February 1, 2010.

CMU has finished the refurbishment of the TMC office space. The office area has been re-painted, recarpeted and new signage installed.

Development has started on an on-line ordering system for reference oils that are not part of the normal TMC reference system. Areas to be featured are Diesel Fuel Lubricity, Elastomer - SF105, SSCT, and Homogeneity and Miscibility in Automotive Engine Oils.

The TMC's internal software infrastructure has been overhauled over the last six months. New Invoicing, shipping and mailing list applications have been rewritten and are now web based.

The TMC website is planned to have increased services added in 2011.

The nominating committee will be electing 4 board members to 2-year terms shortly.

CALIBRATION TEST REPORTING

During the period from June 1, 2010 to December 1, 2010, 2049 calibration tests were reported to the TMC. Virtually 100% of all tests reported to the TMC are transmitted electronically.

ACC MA / ATC ERC PROJECTS

These projects are now in their third year of the four-year contract period. The work continues to progress successfully. ACC has agreed to start discussions with the TMC about the future contract during the 1^{st} quarter of 2011.

Sequence VID baseline and flush oil (~32,000 gallons) approval occurred this period.


