ADMINISTRATIVE/FINANCIAL

The TMC financial audit for the period January 1, 2011 through December 31, 2011 was conducted successfully in March by Lally, Lally & Co. LLC. The current financial status of the TMC will be part of the Administrative Guidance Committee report.

The TMC staff count is now at 15 full-time employees. Sean Moyer was hired in March to oversee heavy duty diesel test area responsibilities and PC-11 development. Robert Bourne was hired in June to supplement our IT staff. No other staff additions are planned. The updated TMC organizational chart is shown in Attachment A.
