3.0) Fuel Supply Update

- 3.1) M-batch adjustment discussion
 - Haltermann is still blending components for pilot batch adjustment.
 - Haltermann estimates the adjusted fuel will be shipped to the labs Thursday, March 13.
 - Haltermann is blending a pilot batch of 7,000 gallons.
 - o Afton, IAR, and SwRI will each receive 2,000 gallons to start the first row of the precision matrix.
 - The total batch is 453,000 gallons.

3.2) Lab Participation in M-Batch Precision Matrix Discussion

- Afton does not agree that Lubrizol should participate in the precision matrix because Lubrizol has not been able to calibrate since July 2024.
- Afton proposes rearrange matrix to only include 3 labs.
- It was proposed that Lubrizol run tests in parallel at Lubrizol's expense that could be included to make the data set more robust.

- If the Lubrizol test results are not deemed valid by the SP, there will still be15 tests from the other 3 labs and not delay the implementation of M-Batch fuel for VH testing.
- Lubrizol may still run in the precision matrix if they have a stand calibrated in time to run ROs 931 and 1011.

Motion by B. Maddock to use precision matrix for 3 labs if LZ is not calibrated in time to run ROs 931 and 1011.
