#### 4.) Old Business

4.1 Update on precision matrix analysis. -Stats Group

-Do we really need to run three RO tests to establish the new engine for LTMS?

-Discussion of reducing the new reference requirement to two oils, then a third oil run after a defined number of candidates.

-Discussion of using FEI 2 and FEI Sum for references to match candidate pass/fail criteria.

-Discussion of evaluating 80/20 ratio of BL before to after for FEI 1 and 10/90 for FEI 2. Consider evaluating FEI 1 vs 100% BLB2 (or 3) and evaluating FEI 2 vs 100% BLA.

-Discussion of changing BLB1 to BLB2 delta acceptable limits. -Determine engine calibration status of matrix engines and date of calibration

-Review impact of variable oil pressure of FEI (review prove out data to determine if it is stand or engine related)

-Should the acceptance bands value of 1.96 be rounded up? Due to the rounding on FEI 1 and 2 the actual pass limit is 1.91 and 1.92.

VIF PM Data Analysis suggests a potential for short engine life similar to the VIE engine life. The stats group will meet on Thursday and will attempt to expand the VIF data analysis before the face to face meeting at IAR. Refer to VIF PM Analysis presentation for more details.

There was a suggestion for a couple of members of the stats group to branch off to focus on the VIF data analysis and attempt to complete it before the meeting at IAR. There was a request for IAR to complete a leak down check on engine 96 and SwRI to complete the same for engine 144. This was requested after noticing that there was an unexpected shift from BLB to BLA during the last tests on these two engines. Request to look at Zi for VID for the first reference period and compare to VIE PM data.

4.3 Update from task force to investigate option to use short blocks to supplement engine inventory. –Adrian Alfonso/Bill Buscher

There are about 450 more complete kits available. There are more short blocks but there are not right heads available. The possibility to reuse/rebuild right heads has to be explored. A survey was sent to all labs to determine the deficit and based on the input from all labs the complete kits and the kits without right heads will be distribute as a percentage of the labs requirement.
