Scott asked if all the labs had received the "temporary" L-33-2 templates. Everyone stated that they had. Scott informed us that the new "final" templates should be available soon and that we would have to contact TMC and order them. The labs are to discard the "temporary" templates when the "final" ones are received.

Scott brought us up to date on the L-60 carbon templates. Lubrizol legal and TMC legal are in the process of coming to an agreement. The templates will be going into Manual 21.

Bill Potocar asked if TMC could supply us with certificates that we completed/participated in the gear workshop. Scott stated that he would.

Scott reminded that all labs to keep up to 6 sets of L-33 gear sets in storage for use at future gear workshops, regardless of the one year storage limit.

After the meeting we began calibration exercises, and then did the calibration data and parts review midafternoon on Tuesday. We then started the "practical application" ratings which took us to the end of the day on Tuesday and continued until after lunch on Wednesday. Practical application data and parts review took place Wednesday afternoon.

The wear target on L-37 pinion gear #56 generated discussion about wear rating.

It was decided amongst the raters that if we wanted to shorten the L-33 axle cover template locating pins that we could, as long as the pins go through the template by at least one inch. This will make the cover much more stable while rating it. Note: if you still need the alignment pins for the "old" Dana hardware, make sure you have 2 sets of pins, and only cut one set

Scott Park and Art Sanchez thanked Lubrizol for their hospitality. There was no other business.

Meeting was closed Wednesday late-afternoon.

Light meter readings were taken both days before we started rating.
